INDEPENDENT PRACTITIONER'S REVIEW ENGAGEMENT REPORT

To the Members of PILOT MOUND & DISTRICT FOUNDATION INC.

We have reviewed the accompanying financial statements of PILOT MOUND & DISTRICT FOUNDATION INC. (the organization) that comprise the statement of financial position as at March 31, 2026, and the statements of operations, changes in surplus and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO), and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements based on our review. We conducted our review in accordance with Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements.

A review of financial statements in accordance with Canadian generally accepted standards for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with Canadian generally accepted auditing standards. Accordingly, we do not express an audit opinion on these financial statements.

Conclusion

Based on our review, nothing has come to our attention that causes us to believe that the financial statements do not present fairly, in all material respects, the financial position of PILOT MOUND & DISTRICT FOUNDATION INC. as at March 31, 2026, and the results of its operations and its cash flows for the year then ended in accordance with ASNPO.

1. DESCRIPTION OF ENTITY

The Pilot Mound & District Foundation Inc. (the "foundation") is a public foundation established to support cultural, educational, recreational and charitable purposes in the Town of Pilot Mound and surrounding area. The foundation's mission is to earn investment income and distribute this income to the community by way of grants or donations. The foundation is a registered public foundation under *The Income Tax Act* and subject to regulations for this type of organization.

2. BASIS OF PRESENTATION

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO). Canadian accounting standards for not-for-profit organizations are part of Canadian GAAP.

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Revenue recognition

The foundation follows the deferral method of accounting for contributions.

Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured. Endowment contributions are recognized as direct increases in surplus.

Investment income in the endowment fund is attributable to both restricted and unrestricted funds. Investment income from restricted funds is recognized as revenue in the year in which the related expenses are incurred. Investment income from unrestricted funds is recognized as revenue when earned. Investment income on endowment funds are not added to the endowment fund.

Financial instruments

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.

Financial assets measured at amortized cost on a straight-line basis include cash, trade and other receivables, and grants receivable.

Financial liabilities measured at amortized cost on a straight-line basis include trade accounts payable and deferred revenue.

Long term investments

Long term investments for which there is not an active market are carried at amortized cost except when it is established that their value is impaired. Impairment losses, or reversal of previously recognized impairment losses, are reported as part of net income.

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(continued)*

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

Contributed services

The operations of the organization depend on both the contribution of time by volunteers and donated materials from various sources. The fair value of donated materials and services cannot be reasonably determined and are therefore not reflected in these financial statements.

4. FINANCIAL INSTRUMENTS

The organization is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the organization's risk exposure and concentration as of March 31, 2026.

(a) Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency rate risk, interest rate risk and other price risk. The organization is mainly exposed to interest rate risk.

(b) Interest rate risk

Interest rate risk is the risk that the value of a financial instrument might be adversely affected by a change in the interest rates. In seeking to minimize the risks from interest rate fluctuations, the foundation manages exposure through its normal operating and financing activities. The foundation is exposed to interest rate risk primarily through its investments upon which interest is earned. The concentration of interest rate risk is nominal.

The James R. Hysop Memorial fund investment income is restricted for scholarships to high school students. The Jeff McCannell Memorial Spirit of Youth fund investment income is restricted for youth purposes. The Cohoe fund investment income is restricted for the the Millennium Centre. The United Church Farquharson Foundation fund is restricted for the Farquharson Foundation Inc. The Kathleen and Harry Steward Music & Art Fund is restricted for art programs at the Pilot Mound School. All other fund investment income is unrestricted.

9. RELATED PARTY TRANSACTIONS

The organization pays a stipend to the executive director of the foundation. Payments during the year were made for the role as the executive director and treasurer. In the current year, the stipend amounted to \$3,300 (2025: \$3,600), this payment is subject to normal trade terms and is measured at the exchange amount.

10. PILOT MOUND & DISTRICT COMMUNITY FOUNDATION AFFILIATE FUND

The Pilot Mound & District Community Foundation Affiliate fund is managed by The Winnipeg Foundation and is based on one-half of the administration fees charged by The Winnipeg Foundation for this management. The balance of the account at year-end is \$106,287 (2025: \$85,812). This is an asset of The Winnipeg Foundation that will annually grow and will help reduce the administration fees for the foundation. These assets are held in trust and not recorded on the balance sheet.
